### Michigan Department of Health and Human Services (MDHHS)

State Emergency Relief (SER) for Housing: Provides housing assistance which may include money for rent, rent arrearage, security deposits, utility security deposits and moving expenses for individuals and families

**How to Apply:** To apply for SER, submit an application to the Michigan Department of Health and Human Services (MDHHS). The application process takes around 10 days to complete. One way to apply is online through the MDHHS website, <u>MI Bridges</u>.

However, if you need immediate help you can also apply in person at your <u>local MDHHS</u> <u>office</u>. Your local MDHHS office will give you an <u>application form</u>, but it may be easier to print an application form and fill it out completely before going to MDHHS. Explain your emergency to your MDHHS specialist. The MDHHS specialist is the only person who can determine whether you are eligible for SER.

### Detroit Housing Network

Detroit Housing Network (DHN) supports homeowners, homebuyers, and renters by providing resources for one-on-one housing counseling and group educational workshops.
