The **State Emergency Relief (SER) for utility-related needs** provides financial assistance to low-income households who meet eligibility requirements **when heating, electric, or water service has been or will be shut off.** SER payments may include the amount needed to restore or continue the service for at least 30 days. It may also include payment of necessary charges to deliver a 30-day supply of a deliverable fuel.

The Fine Print

Before receiving SER assistance, households are expected to make required payments for heat and electric, other utilities, and shelter expenses. Required payments are established amounts that DHHS expects families to spend on their energy bill.

Annual SER assistance is up to <u>\$850</u> for electric, <u>\$850</u> for gas, and <u>\$175</u> for water.

- Demonstration of immediate need (past due/shutoff notice);
 or
- Declared need for a deliverable fuel such as fuel oil; **or**
